

Hawthorn Mall “Holiday Perks Scratch and Win” Sweepstakes  
OFFICIAL RULES

Sweepstakes begins December 15, 2022 and ends December 24, 2022.

- 1. Contest Description:** The Holiday Perks Scratch and Win Sweepstakes will randomly award one sweepstakes winner the daily prize, outlined below, each day during the promotional period of December 15, 2022 and ends December 24, 2022.
- 2. How to Compete:** Contestants can enter by signing up or logging in to MyPerks on their Hawthorn MyPerks App (“the App”) which is free to download on the Apple and Android app stores\*. Contestants must be a Hawthorn Mall MyPerks member, access the app and scratch off their virtual scratch card. One scratch card will be available in the app per day per person. If three like symbols appear once the entire card has been scratched, indicating a win, the contestant will receive an in-app notification with a prompt to input their phone number to receive a text which contains a link to redeem the prize. The link must be displayed to Hawthorn Mall management to redeem the prize. The contestant will win the prize represented for that day of play. Prizes may not be exchanged for cash or prizes from other days of the promotional period.
- 3. No purchase necessary. A purchase will not improve your chances of winning.**
- 4.** Hawthorn Mall is not responsible for lost, late, illegible, mutilated, misdirected or incomplete entries not received by the entry end time, or for any human, mechanical or technological error that may occur in the processing of the entries of this Contest. Responsibility for proper submission of entry rests solely with the entrant. **All entries must be completed and received on the Hawthorn MyPerks App before the entry end time.**

- 12. Disentitlement:** In the event the Contest Winner is disqualified for any reason or chooses not to be the Contest Winner, we will choose an alternate winner at random.
- 13. Winner Notification:** At the reveal of a winning scratch card the Hawthorn MyPerks app will notify the winner in the App and prompt the winner for their telephone number. The telephone number provided must be able to receive text messages and standard text message rates will apply. The winner will receive a text containing a link to the number provided. Clicking on the link will reveal a webpage which must be displayed to

Hawthorn Mall management to redeem the daily prize. Winners will not be notified in any other way. Contest Winners must acknowledge his/her status and complete all the signed documents, in accordance with these Official Rules including a Contest Acknowledgement Release and Waiver at the management office upon redemption of the prize. The Contest Winner must return the Contest Acknowledgement Release and Waiver and any other necessary signed releases and authorizations to Hawthorn Mall or disqualification will result.
