Egg-traordinary Raffle Downtown Palm Beach Gardens Official Rules

NO PURCHASE OR TEXT MESSAGE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: ShopCore Properties, LP. Egg-traordinary Raffle (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry. By entering this Sweepstakes online you agree to receive promotional and marketing communications, including e-mail communications, from Sponsor and each of its affiliates. Otherwise, the "authorized account holder" of a Device is the natural person in whose name the Device has been issued and the services are billed. Potential winners may be required to show proof of being an authorized account holder.

10. Winner Determination and Verification: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of potential winners are final and binding in all matters related to the Sweepstakes. Receiving a prize is contingent upon compliance with these Official Rules. On or about the end of the Promotion Period, Administrator will randomly select the Sweepstakes winners from all eligible entries received. Winners will be notified by email, text message, phone, or mail, depending on the method of entry, after the date of the random drawing. 13. Release: By receipt of any prize, winners agree to release and hold harmless Sponsor, ShopCore Properties LP, PlaceWise Media, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, prize suppliers, advertising/promotion agencies and each of their respective parent

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. This Dispute Resolution section applies to all claims and disputes whenever arising, including

those arising prior to an entrant's acceptance of these Official Rules or the Administrator's Mobile Terms and Conditions.
